Consented planning applications relating to extensions to dwellings granted for the Redington Froggnal Conservation Area are shown for the period 2010 to October 2017.

(32) London Garden City, GiGL.

This is the report of the research undertaken by Greenspace Information for Greater London (GiGL), which quantifies the area of garden space in Greater London.

The research demonstrates a loss of vegetated garden land equivalent to 21 times the size of Hyde Park 1998-99 and 2006-08, representing 3,000ha or a 12% reduction.
