

BGI: SUPPORT FOR LGS DESIGNATIONS

As part of the Regulation 14 public consultation, held between October 2018 and January 2019, opinion was canvassed on the proposed designation of Local Green Spaces.

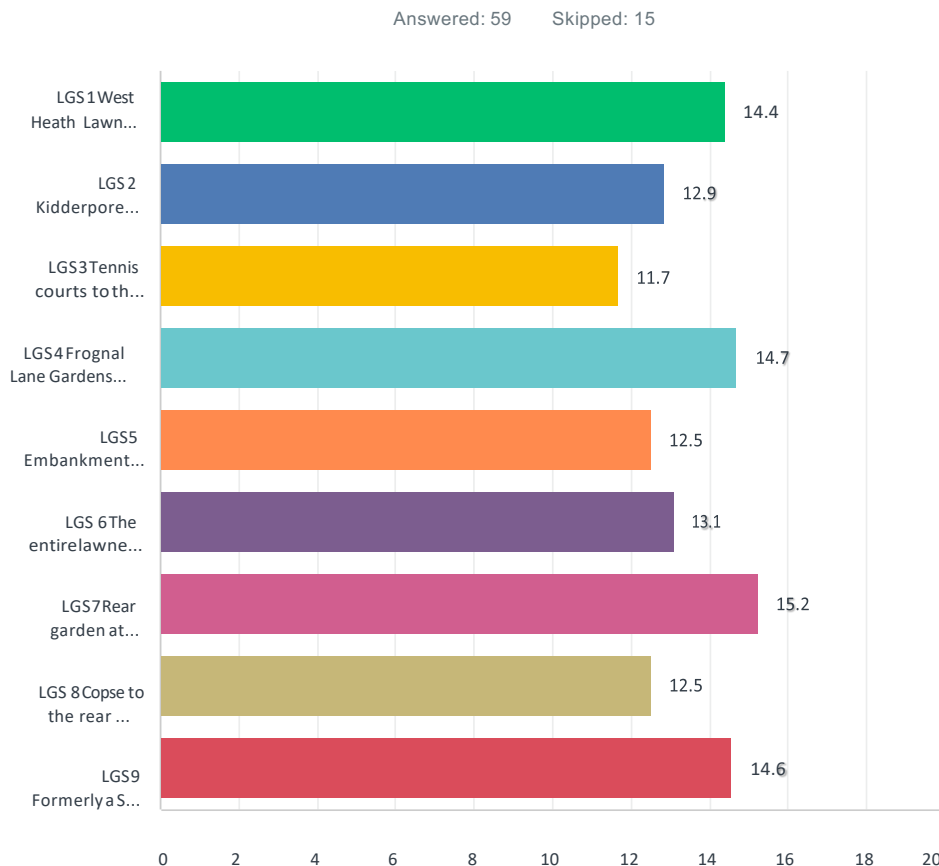
From the question below, high levels of support are indicated for the proposed sites. Following advice, however, designations are no longer being pursued for two of the sites, Kidderpore Reservoir and the tennis courts to the rear of Windsor Court in Platt's Lane.

Support from Neighbourhood Plan - Draft Policies (October 2018)

Q4 Policy BGI 5 - Local Green Spaces. In order to allocate small sites as Local Green Spaces, the Forum are required to show that these areas are "demonstrably special" to the local area and offer a wider community benefit. For example, the site could be visible from the street or from windows of nearby flats; it could support various important trees or provide habitat for wildlife; or an area of tranquility in an urban setting; or have historical significance; or it could provide an opportunity for health and well being, exercise or social interaction.
